

Orthopaedic Foot and Ankle Academic Surgeon



The Department of Surgery (www.surgery.queensu.ca) at Queen's University is seeking an Academic Orthopaedic Surgeon specializing in foot and ankle surgery for a geographically full-time position. The candidate will have completed a minimum of one year of clinical fellowship training at the commencement of their appointment. Additional fellowship training or an advanced degree would also be advantageous. The successful candidate will be expected to have comprehensive clinical expertise in the operative and non-operative management of foot and ankle disorders. The preferred candidate must have an excellent record of success working in a multi-disciplinary clinical environment. They must demonstrate strong potential for outstanding educational contributions and significant academic and scholarly research in line with the mission of the Division of Orthopaedic Surgery. Evidence of current involvement and commitment to research through the submission of a research dossier outlining an academic plan and career goals is requested. Applicants will also be involved in undergraduate and post-graduate medical education. Submission of an educational dossier is encouraged.

Qualified applicants will hold an MD degree (or equivalent), have completed postgraduate / fellowship qualifications prior to appointment, and have or be eligible for licensure with the College of Physicians and Surgeons of Ontario and certification from the Royal College of Physicians and Surgeons of Canada. Preference will be given to candidates with an advanced degree.

The successful candidate will be a full-time member of the Division of Orthopaedic Surgery and participate in the orthopaedic surgery on-call schedule at Kingston Health Sciences Centre. The successful candidate will also be expected to contribute to the teaching, supervision, and mentorship of undergraduate, graduate, postgraduate students and fellows.

Faculty and their dependents are eligible for an extensive benefits package including prescription drug coverage, vision care, dental care, long term disability insurance, life insurance and access to the Employee and Family Assistance Program. Employees also participate in a pension plan. Tuition assistance is available for qualifying employees, their spouses and dependent children. Queen's values families and is pleased to provide a 'top up' to government parental leave benefits for eligible employees on maternity/parental leave. In addition, Queen's provides partial reimbursement for eligible daycare expenses for employees with dependent children in daycare. Applications from all qualified candidates will be considered in the applicant pool. In order to support your employment at Queen's, we require you to indicate whether or not you will need a work permit.

The review of applications is on-going and will continue until the position is filled. Applications are to include a cover letter summarizing expertise, qualifications, and accomplishments relevant to the position, a CV, and the names and full contact information of three referees. The cover letter should also indicate whether or not you will require a work permit and/or require support with an extension of your work permit in the future. Submission of an educational dossier is also encouraged.
